	SEGMENT 2 DRIVER EDUCATION CERTIFICATE

- IF YOU ARE UNDER THE AGE OF 18** your parent or legal guardian must accompany you to and during the test. The vehicle used for the test must be equipped with seats and seatbelts for all occupants (the driver and two passengers). Only the parent/guardian will be allowed to ride along in the vehicle. We do not allow small children to ride during the test. Remember that parent/guardian will be required to sign the "score sheet" certifying that you have completed the 50 hours of driving time (40 daytime/10 night time.)

If during the test, the "Examiner" finds anyone coaching the driver--the test will be terminated immediately!!! The driver will fail the test!!! No refunds.
